 - Addressed many U.S. and EC questions, including status of Galileo concessionaire and process concerning updates to U.S. National Table of Frequency Allocations
 - Initiated joint outreach effort
- Joint fact sheet, Mar 2007
 - Promoting GPS and Galileo as complementary systems for the benefit of end users
- Exchange of letters, Jun-Jul 2007
 - Clarified and documented that all companies are authorized to sell GIOVE-A receivers
- Second meeting, Jul 2008



July 2008 Meeting Summary



- Discussed ideas for expanding joint outreach
- Exchanged info about revised Galileo management structure
- Addressed specific questions about Galileo raised by U.S. industry
- Considered proposals for enabling global equipment manufacturers to develop and test GPS/Galileo receivers on a level playing field
- Exchanged information about U.S. space acquisition processes and policies and the role of European companies in that context
- Initiated limited industry participation



Ongoing Discussion Topics



- Common definition of "non-discriminatory approach" cited in GPS—Galileo Agreement
 - Including applicability of respective WTO commitments to GNSS goods and services
- Terms, conditions, and process for licensing of Galileo Open Service intellectual property
 - Pending EC analysis and subsequent adoption of a IPR policy for Galileo operations under the new Galileo governance
 - "...in due time for allowing the use of the signals broadcasted by the first Galileo satellite in operation"
- Will Galileo be operated as a PPP?
- Expanded U.S. and European industry participation in Working Group B meetings
